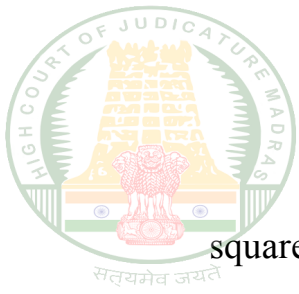

ORDER

This Writ Petition has been filed seeking a direction to the 2nd, 3rd and 4th respondents herein to remeasure the petitioner's property and reinstate patta No.122 situated at Pudhu Kadai Village, Natham Survey No.132/8, 0.0400 square meter which is in the name of Ponnan Son Navan name is present like wise in Patta No.84 situated at Pudhu Kadai village Survey No. 132/9 to an extent of 0.0150 square meter, based on the petitioner's representation dated 15.02.2025.

2. Heard the learned counsel appearing on either side and perused the materials available on record.

3. The petitioner owned a land comprised in patta No.122 situated at Pudhu Kadai Village, Natham Survey No.132/8, 0.0400

square meter which is in the name of Ponnann Son Navan name is present

like wise in Patta No.84 situated at Pudhu Kadai village Survey No.

132/9 to an extent of 0.0150 square meter. In order to survey the said

land, the petitioner submitted an application before the respondents and

also paid requisite fees for the same. So far the respondents did not take

any steps to survey and demarcate the land belongs to the petitioner.

Hence, this writ petition.

4. In view of the above, the second respondent is directed to survey the petitioner's aforesaid land based on the title deed produced by the petitioner, after issuance of notice to the adjacent land owners and counter parties, if any, and to serve the survey report to the petitioner within a period of six weeks from the date of receipt of copy of this order. It is made clear that, if the surveyor concerned is obstructed by third parties while surveying the subject property, the said surveyor can approach the jurisdictional police seeking police aid and on such request, the jurisdictional police shall provide adequate police protection to the surveyor.
