3. The learned Government Advocate (CrI. Side) would also submit that the petitioner has been complying with the condition and final report is not yet filed.

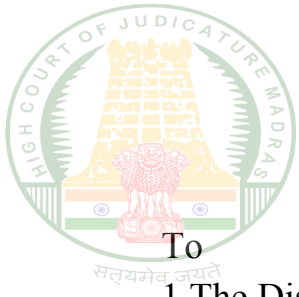
