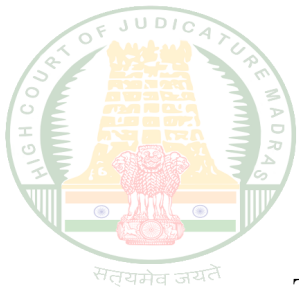

(i) The petitioner/wife is unemployed and is not being maintained by the respondent/husband.

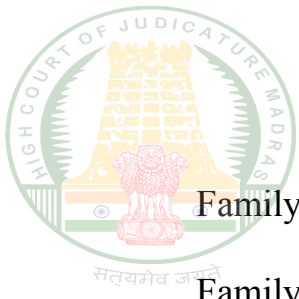
(ii) The petitioner/wife and her children is fully dependent on her parents.
