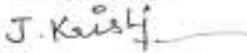
ORDER

The matter was referred to Mediation on 02.12.2024. The Mediator has been successful in settling the matter between the parties. A Joint Memo of Compromise has also been endorsed by the petitioner and the respondent. It reads as under:-

- A. Both the Petitioner and the Respondent agree to file petition for divorce by mutual consent.
- B. The Petitioner agrees to pay the Respondent a sum of **Rs.4,00,000 (Rupees four Lakhs only)** as Permanent Alimony.
- C. The Petitioner agrees to pay **Rs 100000/- (Rupees one lakhs only)** to the Respondent on 2/01/2025.
- D. The Petitioner agrees to pay **Rs 1,50,000 -(Rupees one lakhs fifty thousand only)** on the date of filing the mutual consent by way of **D.D IN FAVOUR OF THE RESPONDENT J.KRISHNAVENI** which is on or before 10/1/2025 and the Petitioner agrees to pay **Rs. 1,50,000(Rupees one lakhs and fifty thousand only)** on the date of recording the evidence in the mutual consent.
- D.The Petitioner hereby agrees to **withdraw the divorce petition** filed by him **O.P.No 4860 of 2022** on the file of Hon'ble IV Additional Family court on the date of filing the mutual consent petition.
- E.The Petitioner hereby agrees to withdraw **C.R.P. 4868 OF 2024** pending before Madras high court on the terms agreed upon by the parties in the **Joint Memo of Compromise agreement**.
- F. The Respondent agrees to **withdraw the maintenance case MC NO. 9 OF 2023** pending before the hon'ble IV ADDL

G. The Respondent agrees to **withdraw the EP FILED 120 OF 2024** ON RECEIVING THE DD IN FAVOUR OF HER ON THE DATE OF FILING THE MUTUAL CONSENT.
