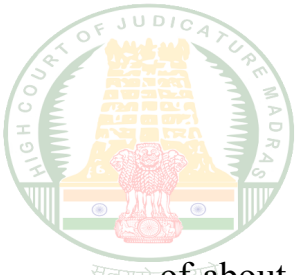

District on the basis of the petitioner's application dated 16.08.2025 with the aid
of the 4th respondent.

2.Mrs.S.Indhu Bala, learned Additional Government Pleader takes notice
on behalf of the respondents 1 to 3 and Mr.L.Baskaran, learned Government
Advocate takes notice on behalf of the 4th respondent. By consent of both the
parties, the main writ petition is taken up for disposal at the admission stage
itself.

3.Learned counsel for the petitioner would submit that though the
petitioner made an application on 16.08.2025, to measure the petitioner's
property, till date the same has not been considered by the respondents 2 and 3.
Hence, he prayed to direct the respondents 2 and 3 to consider and dispose of
petitioner's application dated 16.08.2025.

4.Learned Additional Government Pleader appearing for the respondents

1 to 3 would submit that the representation of the petitioner dated 16.08.2025

will be considered and disposed of within four weeks.

5.Heard the learned counsel for the petitioner; the learned Additional Government Pleader appearing for the respondents 1 to 3 and the learned Government Advocate appearing for the 4th respondent.

6.Considering the submission made by both the parties and in view of the limited prayer sought for in this Writ Petition, without going into the merits of the case, this Court directs the respondents 2 and 3 to consider the application of the petitioner dated 16.08.2025 and dispose of the same on merits and in accordance with law, after issuing due notice to the obstructors, if any. It is needless to state that, if there is any obstruction for measuring the petitioner's land, the respondents 2 and 3 shall complete the process with the aid of the 4th

respondent/Police. Such exercise shall be done by the respondents 2 and 3
