ORDER

This Suo Motu Case is dealt with in an extraordinary manner by the Dedicated Bench, pursuant to Suo Motu.W.P.(Crl.) No.618 of 2025.

2. The case was registered in Cr.No.1165 of 2021 dated 23.11.2021 for the alleged offence under Sections 279, 304(A) of Indian Penal Code, 1860 and 196 and 181(3) of Motor Vehicles Act, 1988. It is reported that in this case, the dependents of the victim have not filed any claim petition. Therefore, the police are directed to serve a set of papers on the family of the victim. The said family are at liberty to file a claim petition, if they so desire and they may also approach the Legal Aid Authority where the legal aid services shall be

provided to them. The quashing of this case will not in any manner come in the way of such claim petition filed. It is submitted that the case is presently pending at the stage of summons and there is no previous or subsequent case against the accused.

3. Considering the factual matrix, context of the case, the antecedents of the accused, the reason for absence from his usual place, and the submission that, despite best efforts, the summons could not be served, it is evident that even if the accused is brought to face trial, it would impinge upon his right to a speedy trial. Due to the passage of time, a meaningful trial is unlikely, and no useful purpose would be served.

4. Accordingly, the case in CC.No.202/2022 on the file of the Judicial Magistrate Court, Rasipuram Taluk, Namakkal shall stand quashed and this Sua Motu Transfer Case stand disposed of.
