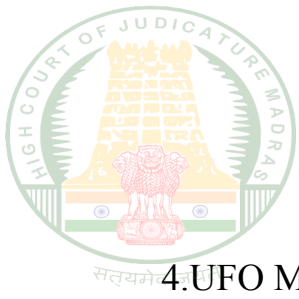

The plaintiff shall carry out the amendments in the Application on or before 14.09.2025 and serve a copy of the amended Application on the other parties.
