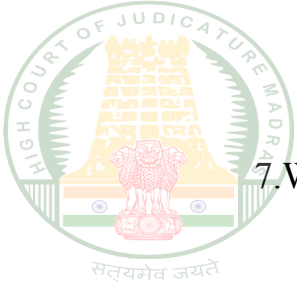
3.Heard the learned counsel for the petitioner as well as the learned Additional Government Pleader appearing for the respondent.
