3.The grievance of the petitioner before this Court is that though at the time of registration of subject property, the petitioner had duly paid the relevant revenue individual patta subdivision process of Rs.1,600/-, the petitioner's name was not updated in his property revenue records and the Officials of the respondents' Department did not conduct any sub-division process. In this regard, the petitioner gave a representation dated 26.07.2025 to the respondents. However, till date the representation of the petitioner dated 26.07.2025 has not been considered by the respondents.

4.Learned Government Advocate appearing for the respondents would submit that the representation of the petitioner will be considered and disposed of within a period of four weeks.
