(Order of the Court was delivered by R.SUBRAMANIAN, J.)

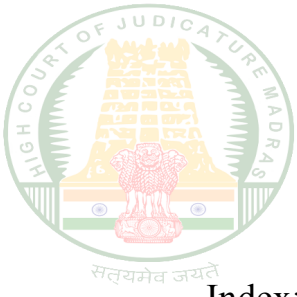
It is now stated that the direction contained in the order dated 27.01.2025 made in this contempt petition have been complied with and the payment has been made.
