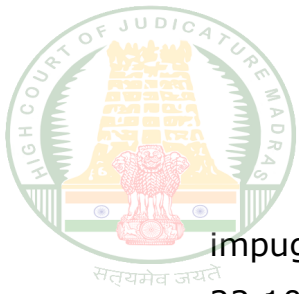

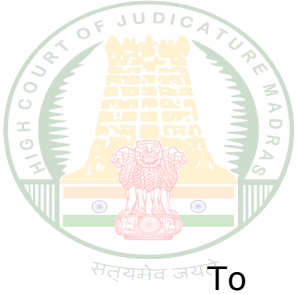
2. Recording the same, the writ petition is dismissed as having become infructuous. No costs. Consequently, connected miscellaneous petition is also dismissed.
