3. Recording the above submissions, this Contempt Petition is closed.

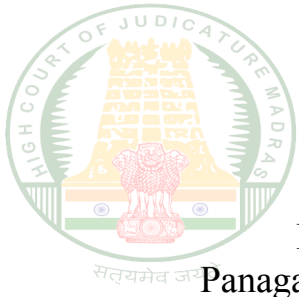
