This order was further confirmed in appeal in W.A.No.1743 of 2012, by order dated 23.07.2021. Hence, this WMP is ordered and the Sangam is impleaded as a party in the present writ petition.

2.Registry is directed to carryout the necessary amendment in the cause title. A status report shall be filed by the 8th respondent as instructed by this Court. Post this writ petition under the same caption on 11.08.2025.
