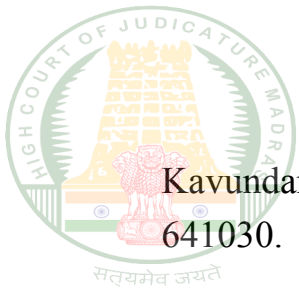

The petition filed for divorce by the respondent is pending before the II Additional Sub Court, Coimbatore. The first petitioner had filed a case seeking maintenance for
