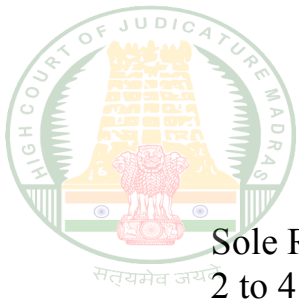

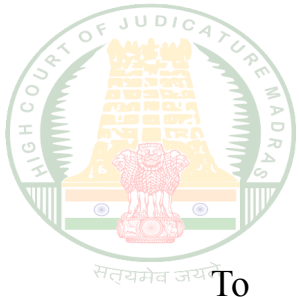
of the fact that the petitioner would be covered by G.O.No.22 dated 28.02.2006 and has directed regularization of the services of the petitioner with effect from 01.07.1992, i.e. completion of 10 years from 01.07.1982.

2. Hence we see no reason to interfere with the order of the Writ Court, the Writ Appeal fails and it is accordingly dismissed. Needless to say, the petitioner will be entitled to all benefits flowing out of such regularization including monetary benefits which shall be computed and paid within a period of twelve (12) weeks from the date of receipt of the copy of the order. There shall be no order as to costs. Consequently, the connected miscellaneous petition is closed.
