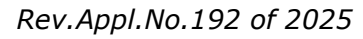
ORDER

2. We have heard *Mr.K.S.Narayanan*, learned counsel for the review applicant and also, we have gone through our order dated 18.08.2025 made in W.A.No.2531 of 2025.
