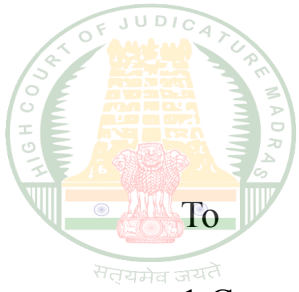
ORDER
