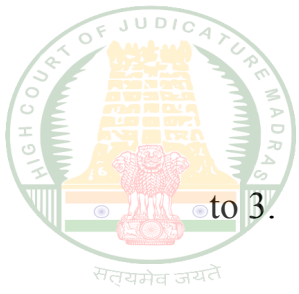

3. The learned Senior Panel Counsel appearing for the respondents 1 to 3 would submit that in the light of the superannuation of the petitioner, question of Voluntary Retirement does not arise.

Moreover, the petitioner is about to retire on 31/3/2025 on account of superannuation. Hence, his request for voluntary retirement cannot be considered at this stage. 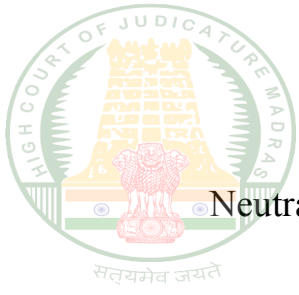
5. In the result, this writ petition is closed. No costs. Consequently, connected Miscellaneous Petition is closed.
