Further, the difference in commuted value of pension Rs.1,03,245/- and the arrears of Revised Pension from 01.06.2022 to 31.03.2024 amounting to Rs.97,682/- was drawn and paid to the petitioner on 06.05.2024. Further it is submitted that no recovery has been made from the petitioner.”*



3. Recording the above, this Writ Petition is disposed of. No costs.
