(Judgment of the Court was made by R.SURESH KUMAR, J.)

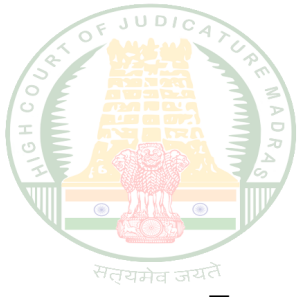
