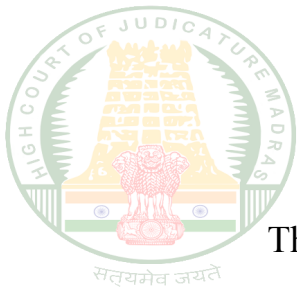

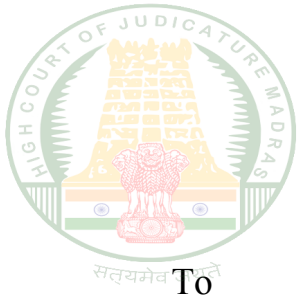
4. In view of the above, these Criminal Original Petitions stand ordered.
