ORDER

The petitioner, who apprehends arrest for the alleged offences punishable under Section 304(2) of BNS 2023, on the file of the respondent police seeks anticipatory bail.

2. The case of the prosecution is that the petitioner along with other

accused is alleged to have involved in the snatching of gold chain of the defacto complainant weighing about $4\frac{3}{4}$ sovereigns. Hence the case.

3. Learned counsel appearing for the petitioner submitted that the petitioner is an innocent person and he has been falsely implicated in this case. He also submitted that based on the confession statement of A1, this petitioner is arrayed as an accused. He further submitted that the petitioner is ready to abide by any stringent conditions that may be imposed by this Court. Hence, he prayed to grant anticipatory bail to the petitioner.

4. Learned Government Advocate (Crl.Side) appearing for the respondent police submitted that there are totally two accused in this case and the petitioner along with A1 had involved in the theft of snatching the gold chain of the defacto complainant. He further submitted that A1 was already arrested and released on bail. The gold chain has been recovered from the accused and there are three previous cases pending against this petitioner. However, he vehemently opposed for grant of anticipatory bail to the petitioner.

5. Heard the learned counsel for the petitioner and the learned



Government Advocate (Crl.Side) and perused the materials available on record.

Taking into consideration the facts and circumstances of this case and the submissions made by the learned counsel on either side and also taking note of the fact that the gold chain has been recovered and the petitioner is ready to abide by any condition imposed of this court, and A1 was already released on bail, this Court is inclined to grant anticipatory bail to the petitioner with certain conditions.

7. Accordingly, the petitioner is ordered to be released on bail on her executing a separate bond for a sum of **Rs.10,000/- (Rupees Ten Thousand only)**, with two sureties (**out of which, one must be a blood surety**) each for a like sum to the satisfaction of the **learned Judicial Magistrate No.1, Sankari, Salem** and on further conditions that:

[a] the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity;

[b] the petitioner shall report before the respondent Police on all alternative days at 10.30 a.m., for a period of three months and thereafter, as and when

required for interrogation ;

[c] the petitioner shall not abscond either during investigation or trial;

[d] the petitioner shall not tamper with evidence or witness either during investigation or trial;

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in ***P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]***;

[f] If the accused thereafter abscond, a fresh FIR can be registered under Section 229A IPC.
