3. The aforesaid statement made by the detenu is recorded. Since there is no illegal detention, this Habeas Corpus Petition is dismissed.

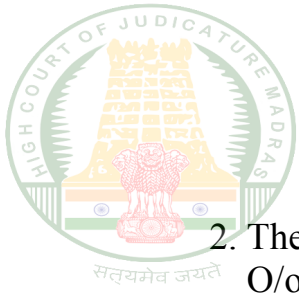
