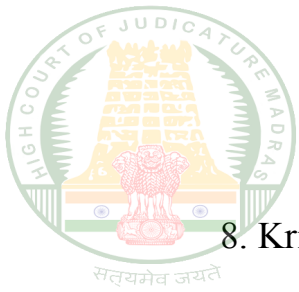

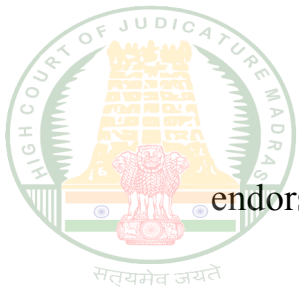

“May be dismissed as withdrawn.”

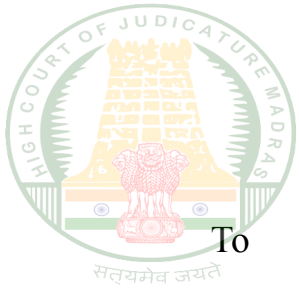
