ORDER

This Sua Motu Case is dealt with in an extraordinary manner by the Dedicated Bench, pursuant to Sua Motu.W.P.(Crl.) No.618 of 2025.

2.The case was registered in Cr.No.33 of 2010 dated 24.01.2010 for the alleged offence under Section 384 of Indian Penal Code, 1860. In this case, the allegation is that the accused threatened the defacto complainant as to why they had stopped on their sister and also picked up a sum of Rs.200 from the pocket of the defacto complainant. The defacto complainant is not traceable. The case is pending from the year 2010. There are no other previous or

subsequent cases pending against the accused. Summon was not served on the accused and consequently, warrant is pending.

3. Considering the factual matrix, context of the case, defacto complainant remains untraceable and the antecedents of the accused, any further continuance of trial would impinge upon the accused's right to a speedy trial. Due to the passage of time, a meaningful trial is unlikely, and no useful purpose would be served.

4. Accordingly, the case in C.C.No.356/2020 on the file of the District Munsif cum Judicial Magistrate Court, Madhavaram Taluk, Tiruvallur, shall stand quashed and this Sua Motu Transfer Case stand disposed of.
