2. This case is registered in Cr.No.732 of 2014 for alleged offence under Sections 427, 447, 294(b) and 506(ii) of Indian Penal Code. The incident occurred during the year 2014. It is further submitted that the defacto complainant does not want to pursue the matter any further. It is reported that there is no previous or subsequent case as against the accused and presently, the case is pending at the warrant stage.

Considering the factual matrix, context of the case, the antecedents of the accused, the reason for absence from his usual place, and the submission that, despite best efforts, the warrant could not be executed, it is evident that even if the accused is brought to face trial, it would impinge upon his right to a speedy trial. Due to the passage of time, a meaningful trial is unlikely, and no useful purpose would be served.

4. Accordingly, the proceedings in C.C.No.700211 of 2015 of Judicial Magistrate No.I, Krishnagiri Taluk, Krishnagiri is quashed and this Sua Motu Transfer Case is disposed of.
