ORDER

This Sua Motu Case is dealt with in an extraordinary manner by the Dedicated Bench, pursuant to Sua Motu.W.P.(Crl.) No.618 of 2025.

2.The case was registered in Cr.No.139 of 2022 dated 16.04.2022 for the alleged offence under Section 379 of Indian Penal Code, 1860. The allegation in this case is that the accused committed theft. It is reported that the stolen property has already been recovered and returned to the defacto

complainant and there is no previous or subsequent case as against the accused. Further, it is submitted that the case is presently pending at the stage of summon. The defacto complainant is present before the Court and has stated that he does not want to pursue the case any further.

3. Considering the factual matrix, context of the case, the antecedents of the accused, the reason for absence from his usual place, and the submission that, despite best efforts, the summon could not be served, it is evident that even if the accused is brought to face trial, it would impinge upon his right to a speedy trial. Due to the passage of time, a meaningful trial is unlikely, and no useful purpose would be served.

4. Accordingly, the case in CC.No.59 of 2022 on the file of District Munsif cum Judicial Magistrate Court, Madhavaram Taluk, Tiruvallur shall stand quashed and this Sua Motu Transfer Case stand disposed of.
