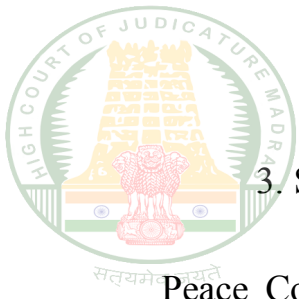
This writ petition has been filed to direct the respondents to consider the representation dated 24.08.2025.
