ORDER

These Sua Motu Cases are dealt with in an extraordinary manner by the Dedicated Bench, pursuant to Sua Motu W.P.(Crl.) No.618 of 2025.

2. In all these cases, the allegation is that the accused was found to be in possession of either 55 litres or 110 litres of either Puducherry or illicit arrack. Even the very identity of the accused is in doubt. It is pleaded that inspite of best efforts summons/warrants could not be served/executed in many of the cases. The sample is also not drawn and sent for analysis. It can also be seen

that there is no other previous or subsequent cases against all these accused and these cases alone are filed against the accused. As such no useful purpose will be served in continuing the cases and as such all these cases are quashed. These Suo Motu Transfer Cases are disposed of.
