and 16(c) of the contract entered into between the petitioner and the respondent and the penalty amount has also been collected from the petitioner. Hence, the present writ.

3.Learned counsel for the petitioner would submit that, in this regard, the petitioner has also submitted a representation, dated 04.10.2023, to the respondent, however, no order has been passed by them.

4.As the petitioner has already submitted a representation dated 04.10.2023 in this regard, let the respondent consider the same and pass orders on merits, particularly taking note of the fact that while granting extension orders, penalty has not been insisted. Such orders shall be passed within a period of one month.

5.With these directions, this writ petition is disposed of. No costs.
