2. The learned counsel for the petitioner submitted that this Court may direct the first respondent to consider and pass orders on the petitioners complaint within the stipulated time as fixed by this Court.

4. Heard the learned counsel for the petitioner and the learned counsel for the first respondent and perused the materials available on record. Since no adverse order is passed against the second respondent, notice to the them is dispensed with.

Considering the facts and circumstances of the case and in view of the limited request sought for by the petitioner, this court directs the first respondent to conclude the proceedings based on the petitioner's complaint after providing opportunity to the petitioner as well as the second respondent within a period of two weeks from the date of receipt of a copy of this order.
