ORDER

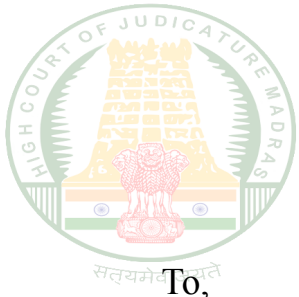
When the matter came up for hearing, the Learned Counsel for the petitioner would submit that they are not pressing the contempt petition.
