ORDER

This Petition is filed to direct the 1st respondent to issue passport to the petitioner by considering petitioner's passport application in Application Reference No.(ARN) 25-1055522549 on 02.07.2025.

2. According to the petitioner, the petitioner is a homemaker and her relatives are settled at abroad and the petitioner intends to travel abroad to visit them. Already the petitioner had a passport and the same was expired on 14.08.2024. Hence in order to travel abroad, the petitioner, again applied for a passport through application on 02.07.2025, however, the same has not been considered, hence seeking to consider the same, the petitioner has filed the present writ petition.

3. The learned counsel for the petitioner contended that it would suffice for this Court to direct the respondents to consider the petitioner's application on merits and in accordance with law.

4. Per contra, the learned counsel appearing for the 1st respondent as well as the learned Government Advocate (Crl.Side) appearing for the 2nd respondent would contend that sufficient time may be granted to consider the representation of the petitioner.

With the above direction, the Writ Petition is disposed of. No costs.
