4. Accordingly, this case in C.C.No.181 of 2020 and the counter case in C.C.No.105 of 2021 on the file of the Judicial Magistrate No.I, Tiruvannamalai Taluk, Tiruvannamalai, shall stand quashed and this Sua Motu Transfer Case stands disposed of.
