**ORDER**

This Sua Motu Case is dealt with in an extraordinary manner by the Dedicated Bench, pursuant to Sua Motu W.P.(Crl.) No.618 of 2025.

2. This case in Cr.No.107 of 2002 was registered for the alleged

offences under Sections 147, 148, 353, 324 r/w.34 of the Indian Penal Code,

1860. It is reported that when the police went for raid to check whether any pirated CDs are there, all these accused have unlawfully joined together and have also attacked the police. In the backdrop of the said allegation and considering the matter is pending from the year 2002, the prosecution also does not want to proceed with the case further.

3. Considering the nature of allegation, the antecedents of the accused, the reason for absence from his usual place, and the submission that, despite best efforts, summons/warrants could not be served, it is evident that even if the accused is brought to face trial, it would impinge upon his right to a speedy trial. Due to the passage of time, a meaningful trial is unlikely, and no useful purpose would be served.

4. Accordingly, the case in CC.No.2401/2011 on the file of the VII Metropolitan Magistrate Court, George Town Taluk, Chennai stands quashed. This Sua Motu Transfer Case is disposed of.
