2. The learned counsel appearing for the 1st respondents seeks adjournment to verify the legal heirs of the deceased 2nd respondent in the writ petition.

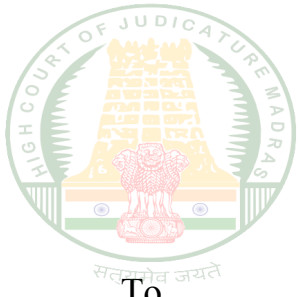
