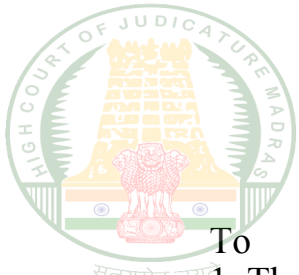
2. Learned Government Advocate (Crl.Side) submitted that the petitioner has been complying with the condition regularly imposed by this Court.
