ORDER

The Criminal Original Petition has been filed seeking to direct the respondent Police to complete the investigation and file a final report in connection with Crime No.29 of 2020 before the appropriate Court within a stipulated time.

Learned counsel appearing for the petitioner submitted that based on the complaint given by the de facto complainant, the second respondent Police registered a case in Crime No.29 of 2020 against the accused.
