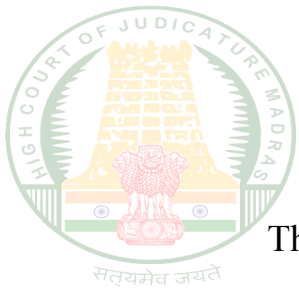

This Criminal Original Petition has been filed directing the learned Principal District cum Sessions Judge, Krishnagiri for Prevention of SC/ST Atrocities to accept the surrender of the petitioner in Crime No.216 of 2025 on the file of the Inspector of Police, HUDCO Police Station, Krishnagiri District) and consequently consider the petitioner's bail application on the same day.

2. In view of the specific bar under Section 18 of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 and also taking into consideration of the possibility of misusing the pious intention of the Parliament against innocent persons, there shall be a direction to learned Principal District cum Sessions Judge, Krishnagiri for Prevention of SC/ST Atrocities, to consider the petitioners' bail application, preferably on the same day of their surrender in connection with Crime No.216 of 2025 on the file of the second respondent and pass appropriate orders in accordance with law, after affording due opportunity to the victims under Section 15-A of the SC/ST (POA) Act, 1989. The petitioners shall surrender before the concerned Jurisdictional Court, within a period of fifteen days from the date of the receipt of a copy of this Order.

3. In view of the above, the Criminal Original Petition stands ordered.
