a)the petitioner was forced to leave her matrimonial home on account of the mental and physical harassment that she had suffered at the hands of the respondent herein.

b)Petitioner would submit that she is taking care of her three year old child without any financial support from the respondent and by filing the above H.M.O.P. before the Sub Court, Uthangarai, the respondent is compelling the petitioner to travel from Chennai to Uthangarai with her child who is not a healthy child.

c)The petitioner is residing within the jurisdiction of the Family Court, Chennai.

3.Heard the learned counsel for the petitioner and perused the records.

4.Considering the above reasons and taking note of the fact that the
