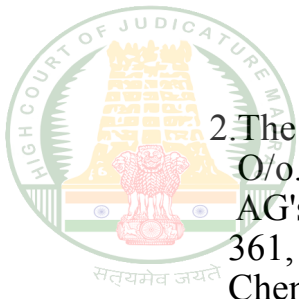

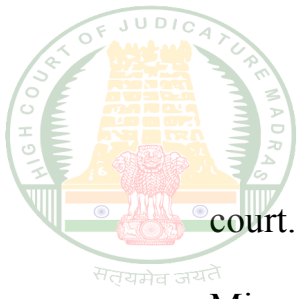

JUDGMENT

(Judgment of the Court was made by ***R.SUBRAMANIAN, J.***)

The appeal is against the very same common order made by the learned single Judge in several writ petitions [W.P.Nos.34752, 34756, 34760, 34764, 34776, 34778, 34779, 34785, 34789, 35242, 35245, 35246 and 35247 of 2022] dated 18.03.2024. A writ appeal in W.A.No.618 of 2025 against W.P.No.34779 of 2022 was filed by the Government and we had, by order dated 10.03.2025, dismissed the said appeal.



2. Hence, we see no reason to interfere with the order of the writ court. This Writ Appeal is **dismissed**. No costs. Consequently, the connected Miscellaneous Petition is closed.
