ORDER

This Writ Petition has been filed for the issuance of Writ of Certiorarified Mandamus, calling for the entire records pertaining to the impugned order No.35015/L1/2018 dated 10.05.2019 passed by the second respondent and quash the same as illegal, arbitrary and devoid of merit and consequentially direct the Respondents to deposit the compensation of Rs.3230 per square meter for NANJA land classification in Main Survey No.14 and its sub division in Thunjam village, Thirukazhukundram Taluk, Kanchipuram District.

2. When the matter is taken up for hearing, the learned counsel for the petitioner would submit that the sole petitioner died long back. However, so far the legal heirs of the deceased petitioner did not any steps to substitute themselves as legal heirs of the deceased petitioner. It shows that they have no interest to proceed the writ petition further.
