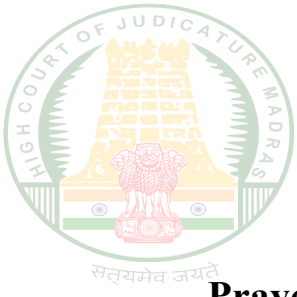

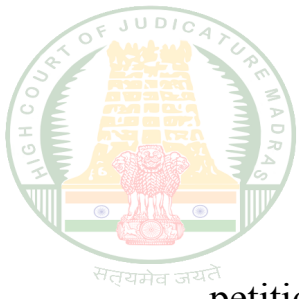

The learned counsel for the petitioner would submit that the petitioner was a part of a Committee to inspect Vels Medical College and Hospital at Velan Nagar, Manjakaranai Village, Uthokottai Taluk, Thiruvallur District, in the year 2020. After an inspection, the Committee filed a detailed report and based on the report given by the Committee, the Government of Tamil Nadu as well as the National Medical Commission had given a Letter of Permission, to the concerned College. However, without taking into consideration the same, the respondents have issued a charge memo to the petitioner, after a period of 4 years.

3. The learned counsel for the petitioner would submit that though the challenge is made to the charge memo, it would suffice if the 2nd respondent is directed to complete the disciplinary proceedings, within a specified period fixed by this Court.

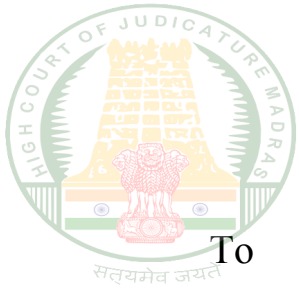
