ORDER

The petitioner, who was arrested and remanded to judicial custody on
08.08.2025 for the alleged offence under Sections 24(1) Cigarette and
Other Products Acts 2003 and Section 77 of the Juvenile Justice (Care and
Protection of Children) Act 2015 in Crime No.455 of 2025 on the file of the
respondent police, seeks bail.

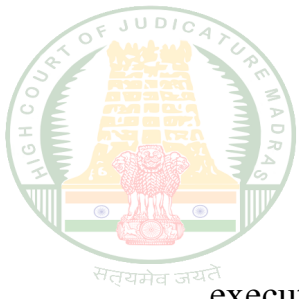
2. The case of the prosecution is that the petitioner was found in possession of banned Tobacco products of 20 kgs and selling it to the general public. Hence, the case was registered against the petitioner.

3. The learned counsel for the petitioner would submit that a false case has been foisted against the petitioner. He would also submit that the petitioner was arrested and remanded to judicial custody on 08.08.2025. Hence, he prays for grant of bail to the petitioner.

4. The learned Government Advocate (Crl.side) would submit that the petitioner was found in possession of banned Tobacco products of 20 Kgs and selling it to the general public. He further submit that no previous case is pending against this petitioner. Hence, he opposed for grant of bail to the petitioner.

5. Heard both sides and perused the materials available on record.

6. Considering the facts and circumstances of the case, nature of allegations, submissions made by learned counsels on either side and considering the fact that there is no previous case pending against the petitioner, this Court is inclined to grant bail to the petitioner with certain conditions.

7. Accordingly, the petitioner is ordered to be released on bail on his executing a bond for a sum of **Rs.20,000/- (Rupees Twenty Thousand only)** with **two sureties**, for a like sum to the satisfaction of the **learned Judicial Magistrate No.II, Coimbatore** and on further conditions that:

[a] the sureties shall affix their photographs and Left Thumb Impression in the Application for Surety ship [Judicial Form No.46 annexed to 'The Criminal Rules of Practice, 2019']. The learned Magistrate shall obtain a copy of any one of the identity proofs to ensure their identity;

[b] the petitioner shall report before the respondent police for a period of three weeks and thereafter, as and when required for interrogation;

[c] On breach of any of the aforementioned conditions, the learned Magistrate/Trial Court is entitled to pass appropriate orders against the petitioner in accordance with law as if the aforementioned conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji vs. State of Kerala [(2005)13 SCC 283]**;

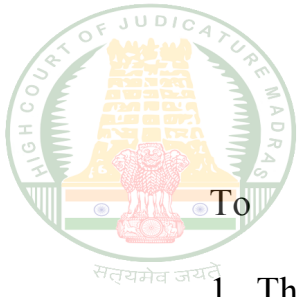
[d] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 of B.N.S.
