ORDER

The Criminal Original Petition has been filed seeking a direction to the respondent Police not to harass the petitioner under the guise of investigation/enquiry.

2. It is the grievance of the petitioner that under the pretext of enquiry, the respondent Police are unnecessarily harassing the petitioner.

3. The learned Government Advocate (Criminal Side), on instructions, submitted that based on the complaint given by the third respondent, the petitioner was called for an enquiry and was not harassed by the respondent Police.

4. In such circumstances, it is for the Investigating Agency to issue appropriate notice to the petitioner under Section 35(3) of BNSS for enquiry and on receipt of such notice, the petitioner shall appear for enquiry and co-operate with the investigation. If any cognizable offence is made out, the respondent Police shall register the First Information Report and proceed as per law.
