ORDER

This Sua Motu Case is dealt with in an extraordinary manner by the
Dedicated Bench, pursuant to Sua Motu.W.P.(Crl.) No.618 of 2025.

2.The case was registered in Cr.No.1396 of 2011 for the alleged offence
under Section 399 r/w 34 of Indian Penal Code, 1860. The allegation in this
case is that the accused persons gathered in night with weapons to plan a
robbery in jewellery shop. It is reported that the case is presently pending at

the stage of warrant and the prosecution does not want to pursue the case any further.

3. Considering the factual matrix, context of the case, the antecedents of the accused, the reason for absence from his usual place, and the submission that, despite best efforts, the warrant could not be executed, it is evident that even if the accused is brought to face trial, it would impinge upon his right to a speedy trial. Due to the passage of time, a meaningful trial is unlikely, and no useful purpose would be served.

4. Accordingly, the case in P.R.C.No. 64 of 2012 on the file of VIII Metropolitan Magistrate Court, George Town Taluk, Chennai shall stand quashed and this Sua Motu Transfer Case stand disposed of.
