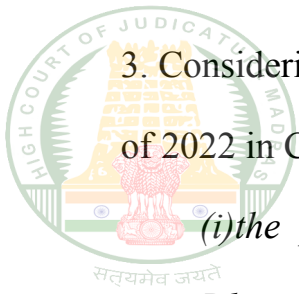

ORDER

(Order of the Court was made by the Hon'ble M.S.Ramesh, J.)

This petition has been filed to relax the condition imposed by this Court vide its order dated 18.11.2022 in CrI.M.P.No.17293 of 2022 in CrI.O.P.No.10191 of 2019, that to appear and sign before the Deputy Superintendent of Police, Q Branch, CID, Coimbatore.

2.Learned Additional Public Prosecutor, on instructions, submitted that the petitioner has been complying with the the conditions regularly.



3. Considering the said submission, the condition imposed by this Court in Crl.M.P.No.4104 of 2021 in Crl.O.P.No.10191 of 2019 on 18.11.2022 is hereby modified as below:

(i) the petitioner shall appear and sign before the Principal Sessions Court, Dharmapuri, on the 1st Monday of every English Calendar month at 10.30 a.m., until further orders. It is also submitted that final report has been filed in the case before the trial Court. Therefore, it is made clear that the petitioner shall appear before the trial Court on all hearing dates. He is exempted from appearing before the Principal Sessions Court, Dharmapuri, on those dates when he has to appear before the trial Court for hearing.

(ii) The petitioner shall appear before the trial Court on all hearing dates.

4. All other conditions imposed in Crl.M.P.No.4104 of 2021 in Crl.O.P.No.10191 of 2019 on 15.04.2021 shall stand unaltered.
