ORDER

This Sua Motu Case is dealt with in an extraordinary manner by the Dedicated Bench, pursuant to Sua Motu W.P.(Crl.) No.618 of 2025.

2.The case in Cr.No.199 of 2019 was registered for the alleged offences under Sections 457 and 380 of the I.P.C. The allegation in this case is that the accused committed theft of certain property belonging to the complainant. It is reported that the property has been recovered and handed over to the complainant and the complainant does not want to pursue the case any further.

3.Considering the factual matrix, context of the case, the antecedents of the accused, the reason for absence from his usual place, and the submission that, despite best efforts, the summons could not be served, it is evident that even if the accused is brought to face trial, it would impinge upon his right to a speedy trial. Due to the passage of time, a meaningful trial is unlikely, and no useful purpose would be served.

4. Accordingly, the case in C.C.No.18 of 2021 of District Munsif cum Judicial Magistrate Court, Thirukalukundram Taluk, Chengalpattu, stands quashed. This Sua Motu Transfer Case is disposed of.
