ORDER

The petitioner, who was arrested and remanded to judicial custody on 31.08.2025, for the offences punishable under Sections 8(c), r/w 22(b)(ii)(A) and 29(1) of NDPS Act and Section 77 of Juvenile Justice Act in Crime No.468 of 2025, registered on the file respondent police, seeks bail.

2. The case of the prosecution is that on 31.08.2025, while the respondent police were patrolling near Valasaiyur Government Higher Secondary School, the petitioner along with other accused were found in illegal possession of 25 grams of ganja for selling the same to the school and college students. Hence, this case.

3. The learned counsel appearing for the petitioner submitted that the petitioner is a college student and he has been falsely implicated in this case and he is in judicial custody since 31.08.2025; and that the petitioner is ready to abide by any conditions that may be imposed by this Court and sought for bail to the petitioner.

4. The learned Government Advocate (Criminal Side) appearing for the respondent while opposing the bail to the petitioner, reiterated the prosecution case and stated that there are totally three accused and the petitioner is arrayed as A3, who is a college student and he was found in possession of 25 grams of ganja; and that the investigation is pending.

5. Considering the facts and circumstances of the case, the quantity of contraband seized, the petitioner being a college student and the period of incarceration undergone by the petitioner, this Court is inclined to grant bail to the petitioner with certain conditions.

6. Accordingly, the petitioner is ordered to be released on bail on his executing a bond for a sum of **Rs.25,000/- (Rupees Twenty Five Thousand only)** with **two sureties**, for a like sum to the satisfaction of the **learned Judicial Magistrate, Salem** and on further conditions that:

[a] the sureties shall affix their photographs and Left Thumb Impression in the Application for Surety ship [Judicial Form No.46 annexed to 'The Criminal Rules of Practice, 2019']. The learned Magistrate shall obtain a copy of any one of the identity proofs to ensure their identity;

[b] the petitioner shall report before the respondent police daily at 10:30 a.m., for a period of two weeks and thereafter, as and when required for interrogation;

[c] On breach of any of the aforementioned conditions, the learned Magistrate/Trial Court is entitled to pass appropriate orders against the petitioner in accordance with law as if the aforementioned conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji vs. State of Kerala [(2005)13 SCC 283]**;

[d] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 of B.N.S.
