The same is recorded.

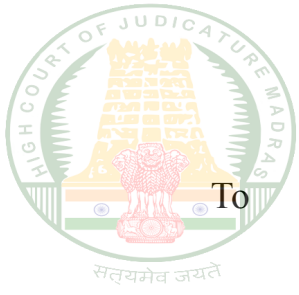
